Accountabilities

Specific accountabilities for this role include:

Academic guidance:

Foster a welcoming and confidential environment for one-on-one academic advising by:

- helping students understand program requirements, select courses in accordance with their specialisation requirements and develop academic plans that align with their goals and ensure timely graduation.
- supporting students to explore and identify the right specialisation through utilising their knowledge of the field.
- assisting students considered at risk to identify academic challenges and needs and develop effective strategies for success.
- helping students be aware of UNSW policies related to academic standing rules, maximum repeat fails, maximum time to complete program.
- informing students about the Academic Progression and Enrolment Policy and implications of not meeting progression rules.
- supporting students with the special consideration process and referring them to the DVCSE Student Support team for assistance with formatting their written submissions.
- supporting students at risks and students returning from suspension to develop enrolment/study plan
 to resume progress in their study.

- Informing students of other relevant support services available to them, including, the Student Support team, Equitable Learning Services and Health and Wellbeing services.
